The Board of Directors have had complaints over the years from all parts of the estates regarding boats, boat trailers, construction trailers and utility trailers being left outside over night and some being stored on a consistent basis on the property.

In addition, in some areas of the subdivision residents are storing unlicensed vehicles on a long term basis. These vehicles at times set with flat tires and appear almost as abandoned.
